Founded in 1847 by Mary Hargrove Haller, who bought 100 acres for the townsite; she named the town for her grandfather, Robert Wooding Chappell, an early settler.

Chappell Hill offers a history rich in culture, higher education, sandbars and stern-wheelers, cotton, War-Between-the-States, and Polish immigration. The history of Chappell Hill is told through exhibits, documents, and photos at the Museum on Poplar Street. We had a wonderful tour guide that explained the History of this town and answered all our questions. The Historic Methodist Church is located adjacent to the Museum. Main Street offers the Visitor's Center, Providence Baptist Church, the Old Rock Store, and the 1907 Historic Bank (presently Chappell Hill Bank) which still operates since ever.

We stopped at Larry's BBQ in Houston for our lunch. Everyone had an enjoyable time.

Benefits payments go digital to save money


(Effective 3/1/2013)



Starting March 1, 2013, the Treasury Department is requiring that all Social Security, VA, SSI and other federal beneficiaries receive their benefits by ELECTRONIC PAYMENT. Senior citizens and other federal beneficiaries may choose either direct deposit or the Treasury-recommended Direct Express Debit MasterCard.

This new payment method is **NOT** optional. It is the law. Besides saving taxpayers money, switching to electronic payments provides a safer, more convenient and cost-effective way for people to get their federal benefits than paper checks.

Individuals who need assistance in switching to electronic payment can call the Treasury's secure Go Direct Call Center at 800-333-1795. Our agents are specially trained to answer questions and complete the switch-over process in less than 10 minutes.

Definition

Shingles is a viral infection that causes a painful rash. Although shingles can occur anywhere on your body, it most often appears as a single stripe of blisters that wraps around either the left or the right side of your torso.

Shingles is caused by the varicella-zoster virus the same virus that causes chickenpox. After you've had chickenpox, the virus lies inactive in nerve tissue near your spinal cord and brain. Years later, the virus may reactivate as shingles.

While it isn't a life-threatening condition, shingles can be very painful. Vaccines can help reduce the risk of shingles, while early treatment can help shorten a shingles infection and lessen the chance of complications.

Symptoms

The signs and symptoms of shingles usually affect only a small section of one side of your body. These signs and symptoms may include:


- Pain, burning, numbness or tingling
- A red rash that begins a few days after the pain
- Fluid-filled blisters that break open and crust over
- Itching

Some people also experience:

- Fever and chills
- General achiness
- Headache
- Fatigue

Pain is usually the first symptom of shingles. For some, it can be intense. Depending on the location of the pain, it can sometimes be mistaken for a symptom of problems affecting the heart, lungs or kidneys. Some people experience shingles pain without ever developing the rash.

Most commonly, the shingles rash develops as a stripe of blisters that wraps around either the left or right side of your torso. Sometimes the shingles rash occurs around one eye or on one side of the neck or face.



The shingles rash is associated with an inflammation of nerves beneath the skin.

When to see a doctor ... Contact your doctor promptly if you suspect shingles, but especially in the following situations:

- The pain and rash occur near an eye. If left untreated, this infection can lead to permanent eye damage.
- You're 65 or older, which increases your risk of complications.
- You or someone in your family has a weakened immune system (due to cancer, medications or chronic illness).
- The rash is widespread and painful.


