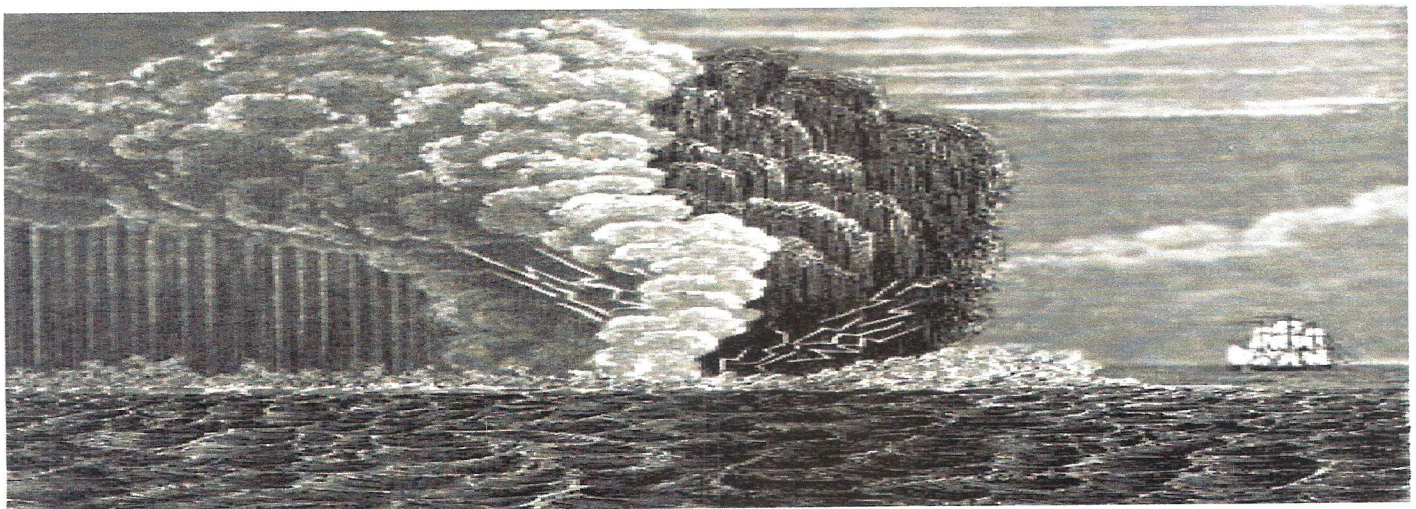

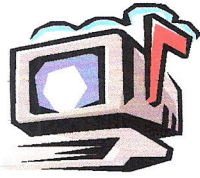

United Air Lines put on trial as deaf man fights for job

John Sprague was flying high when he was offered the job as a mechanic for United Air Lines. But Sprague's career crashed and his future stalled when two days before he was to start, the company withdrew its offer. "I was very hurt," said Sprague, 38, of Grafton, who was rejected because he is deaf. "It had always been my dream and goal," he said. Sprague, who holds both mechanic's and pilot's licenses, was so sure he could do the job he decided to fight, filing suit against the mammoth company in 1997.

His trial began yesterday in federal court. He, his deaf wife and daughters all watched from the gallery aided by a sign language translator. "This is a classic case of discrimination under the Americans With Disabilities Act," said his lawyer, Harold Lichten, in opening statements before Judge George O'Toole, who will decide the case without a jury. "There are no peripheral issues. United Air Lines concedes the sole reason it rescinded a job offer as line mechanic at Logan Airport is because he is deaf. They did so based on the most stereotypical assumptions imaginable. They thought he was completely deaf and wouldn't be able to hear critical warning sounds," said Lichten. They never bothered to check, argued Lichten. With the help of two digital hearing aids, Lichten said, Sprague can hear most of what he needs to do the job - testing and repairing planes coming in and out of Logan.

In fact, Sprague, who worked as mechanic at Taunton Airport for 13 years before applying to United, is now working as a mechanic for AirTran, an airline based in Fort Lauderdale. His current supervisor is expected to testify on his behalf.

United lawyers said real safety concerns prevented them from making good on the job offer. Mechanics must check out entire airplanes, including entertainment systems and flight recorders. Sprague couldn't perform those duties, said attorney Douglas Dexter, nor could he communicate with other mechanics, pilots, the air traffic tower or maintenance headquarters in San Francisco. "(Mechanics) may need to contact San Francisco by telephone when there's a serious problem - when they make a potentially life-threatening decision about whether an aircraft can take off," Dexter said. "He cannot communicate or hear the words," he said, adding that "safety is an overriding concern." The company did offer Sprague another job, but he wants the one he was promised. "We're very conscious of our responsibilities as they relate to the Americans With Disabilities Act," said United spokeswoman Susana Leyva.

She explained about how CRR helped her to become more comfortable with many word processing features, as well as using Windows 98. She was proud to mention that she's working for Deaf Senior Citizens Newsletter and secretary for St Dominic Deaf Club. She also mentioned that the number of deaf people attending CRR is growing. More importantly she has come to realize that with proper training, deaf persons can do just as well as any hearing person.



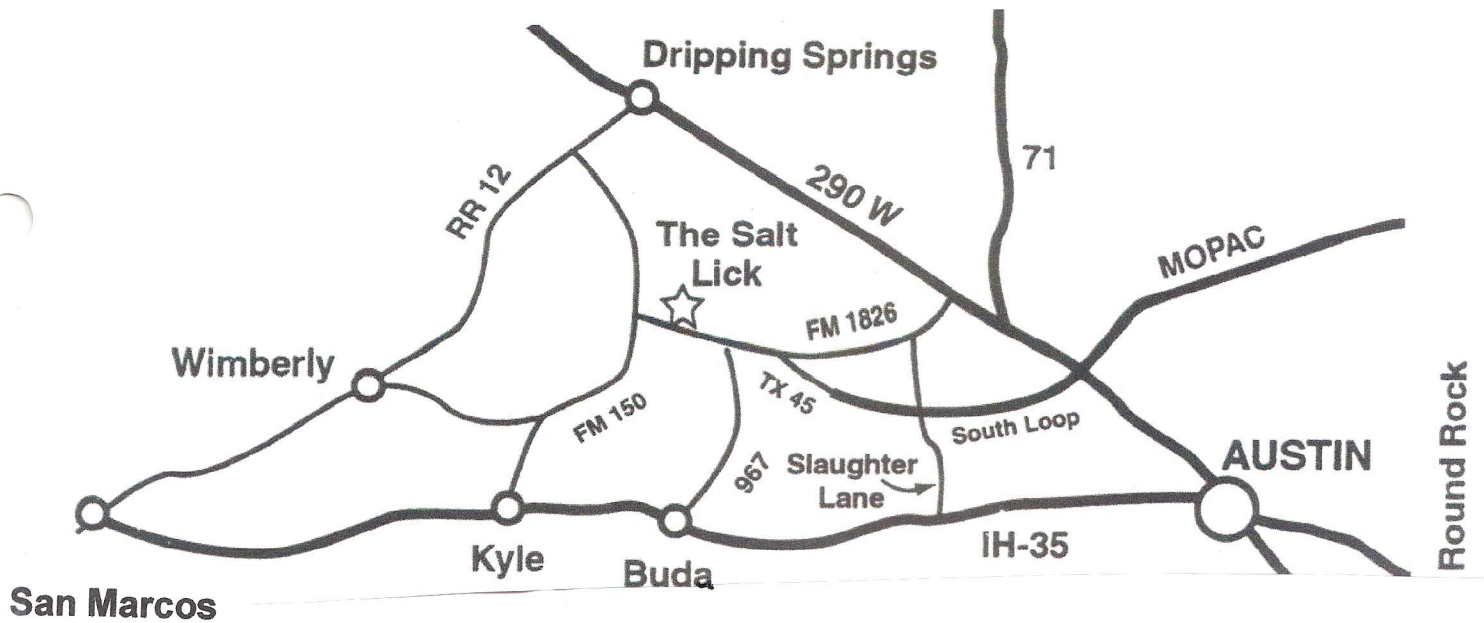

SOUTH ON LOOP 1/MOPAC

Head south on Loop 1 (Mopac) and take it all the way to the end at FM 1826. Turn left onto FM 1826 and go 7.3 miles. The Salt Lick is on the right.

TAKE IH 35 SOUTH

Exit right on Slaughter Lane. Go west on Slaughter until it dead-ends into FM 1826. Make a left and The Salt Lick is approximately 10 miles on right.

FROM SAN ANTONIO/NEW BRAUNFELS/SAN MARCOS

Take IH 35 North and pass through San Marcos. Exit right on Hwy 150 (Kyle exit). Turn left over the I-35 overpass into Kyle. At second stop sign, make a right onto FM 150. Continue approximately 9 miles. Follow FM 150 to the right towards Driftwood. Pass through Driftwood and FM 1826 (Camp Ben McCulloch Road) will be on right. Turn right and The Salt Lick is 1 mile on left (past the bridge).

FROM "Y" AT OAK HILL

Go west on Hwy 290. At 3rd light (across from Circle K) turn left onto FM 1826 (Camp Ben McCulloch Road). The Salt Lick is approximately 13 miles on the right.

FROM WIMBERLY

Take 3237 to FM 150 & turn left onto FM 150. Drive approximately 5 miles until you reach FM 1826. Turn right & Salt Lick is 1 mile on left (past the bridge).

FROM DRIPPING SPRINGS/JOHNSON CITY

HPD responds to the needs of deaf and hard of hearing

The Houston Police Department (HPD) recently marked its 13th year of work on behalf of the Houston's hearing-impaired community at its monthly meeting at the Woodhaven Church for the Deaf and Hard of Hearing, 9920 Long Point.

Mayor Lee Brown was among officials in attendance, sending a signal to Houston's Deaf and Hard of Hearing that their rights are acknowledged.

It all started in August 1987 when two HPD officers, who had been taking sign language classes, visited Woodhaven's congregation as part of HPD's Positive Interaction Program, under the direction of Officer Randy Melton. Their objective was simply to interact with those present and to answer any questions they might have had with regard to HPD and its procedures.

"The audience froze. They were flat afraid, said Melton. "The deaf are inherently afraid of uniformed police officers."

The PIP officers tried again several weeks later, when 11 people showed up at the pastor's urging. Still no questions.

The National Association of the Deaf estimates there are 1.7 million hearing-impaired people in Texas. From a police officer's perspective, Melton said, being deaf can't be recognized visually.

During the past 13 years, Melton has come to realize the difficulties of communicating with hearing-impaired individuals. Unfortunately, up to this point, police officers have been trained only in a hearing arena.

On the flip side, Melton has aimed at dispelling fears of hearing-impaired people by helping them understand the police officer's training and perspective.

With these dual objectives in mind, Melton has set the following programs in motion:

- An elective eight-hour class is offered to HPD officers. The class helps them address the special needs of the hearing-impaired and examines the cultures of hearing-impaired people who sign, don't sign and those who are orally deaf. Participants become familiar with devices typically used by the hearing-impaired and associated medical conditions,

such as a physical imbalance.

- HPD officers may take a 12-week American Sign Language class at Houston Community College. Those who pass receive three hours of college credit in a foreign language and Texas law enforcement accreditation hours.
- HPD hosts monthly meetings at Woodhaven Church for the Deaf to share how different HPD divisions operate and explore how it might better serve the hearing-impaired.
- In an attempt to dispel their fears, HPD invites members of the hearing-impaired community to ride along with police officers on their beats.
- HPD networks with approximately 40 other U.S. law enforcement agencies to exchange ideas pertaining to communicating with the hearing-impaired.
- Melton maintains contact with three different coalitions and task forces for the Deaf and Hard of Hearing, including the Self Help for the Hard of Hearing as well as NAD.

Melton presented a workshop entitled "Understanding the Police Culture" during SHHH's 14th annual international convention, which was held in June in St. Paul, Minn.

HPD's work is spurred by two recent legal settlements involving hearing-impaired people.

On July 14, a federal jury in Brownsville found that Victoria County violated Butch Pyle's rights following an auto accident and awarded him \$230,000. Pyle, who has been deaf since birth, didn't understand the arresting officer's orders.

In March, HPD settled complaints with the Justice Department concerning the arrest of two deaf men in 1996.

HPD and other government agencies are ensuring that the rights of hearing-impaired people are protected.

"HPD is working very hard to work with the Deaf and Hard of hearing," Melton said.
