





### Westbanker is dentist for the deaf Jerry Katz improves patients' smiles, heightens self-esteem

Smiles are Jarry Kata's specialty. Every day, the Westbanker dentist uses his ery day, the Westbanker dentist uses his profession as an avenue to be an ambitious student, an empathetic listener and also a friend to his patients, many of whom are deaf. Katz was nominated as Outstanding Dentist of the Year in 1994 by the Texas Chapter of the Academy of General Dentistry.

Although not deaf himself, Katz was raised by two deaf parents. He said that

Although not dear nimself, Katz was raised by two deaf parents. He said that the experience brought with it a set of unique responsibilities.

"One thing that happens in a deaf home when you're a hearing child is you take on a lot of adult responsibilities of communicating for the family," Katz said.

But Katz hea only positive representations

But, Katz has only positive memories of his childhood.

"I grew up in a very loving, supportive home and really, my parents never like it was a handicap," Katz said.

After many years of communicating with deaf people, Katz said he became flu-

ent in sign language and also became senand also became sen-sitive to deaf people's disadvantages of liv-ing in a "hearing" world. He said that one of their biggest frustrations is not being able to thoroughly communicate with their doctors. Relieving this frus-tration is one of Katz's primary goals. In his dental practice, Katz treats more than 100 deaf patients for routine dental care. And aside from his regu-lar schedule, for the past five years, Katz has provided preven-tative dental screenDr. Jerry Katz was nominated for 1994 ings for students at Dentist of the Year. "It's a lot of fun because immediately
they relate to me," Katz said, "because I
can really communicate with them fluent-

the patient's anxiety, Katz said.

"You can see how comfortable they get," Katz said. "It's almost beyond communicating just the facts. It's the fact that I'm assimilated into their deaf culture. I'm sensitive to how they feel and in a lot of ways to how they think."

Besides participating in dental care for the deaf, Katz is also on the board for the

Travis County Council for the Deaf, who would a interpretive services for the deaf

Travis County Council for the Dear, which provides interpretive services for the deaf, "Our main focus right now is trying to create a community center for the deaf," Kats said. "We have an unusually large deaf community for a city the size of Austin, and we have no community centers."

Establishing relationships with all of his patients is first on Katz's agenda. He commences each appointment by taking them into his personal office, filled with pictures of his family, and asking them to express their concerns. He said that being sensitive to their needs, hearing their con-


express their concerns. He said that being sensitive to their needs, hearing their concerns, and trying to react with treatment that's appropriate aids in lessening patients' anxiety.

"I think today people want to be informed of all their options," Katz said. "And they would like support from their doctor's experience to help them make a choice."

Part of being a knowledgeable professional, according to Katz, is staying up-to-date on technological advancements in dentistry and continuing to learn from ex-

perts in the field.
"Being up on the latest techniques, materials and practices that were going on always kept me motivated and very enthu-siastic about my profession." He

After graunating from the Texas at Austin, then from the UT dental branch in Hous-ton, Katz continued to take ongo-ing educational courses in dentistry. And his ef-forts were recognized by others



earned my fellowship in the Academy of General Dentistry for taking over 500 hours of continuing education." Katz said. Katz said he has taken to heart the

Katz said he has taken to heart the teachings at a particular dental institute, L.D. Pankey, which was named after an exceptional dentist.

"It's about in your dentistry really striving for nothing but excellence," Katz said, "and always being more focused on what service you're giving to your patient than what you're receiving."

Rejeing a person's self-esteem through

Raising a person's self esteem through dental treatment is something that Katz hopes to accomplish. "It can be really disabling if a person

doesn't feel confident about themselves be-cause of their smile," Katz said. "It's a very important asset in the way they present, and I've found that if you can help them with that, there's an awful lot of appreci-

ation on the patient's part."

Katz said he was always interested in seeking a profession in the medical field because he thought it offered a chance to succeed personally, and at the same time provided a service to the community. Choosing to become a dentist rather than a physician was based on his pleasant childhood dental experiences.

"I remember really liking my dentist,"

in rememor really liking my dentist, he said. "I felt very safe whenever I was in his chair. And I think that was probably one of the reasons that helped me make my mind up about going into dentistry."

Helping people feel better about themselves also makes Katz feel valuable as a person and as a dentist. Katz recalls one

woman patient who told her husband for their 25th wedding anniversary she want-ed a beautiful smile. After dental treatment, others noticed her higher self-es-

teem.
"Her family members called and said how much the dental work had changed her personality," Katz said. "They said she was more outgoing and more active."

"I find that very exciting; it's spiritually very rewarding," he also said.
Katz's wife, Carrin, and their two sons,

David and Steve, have been influenced by Katz' profession. Carrin Katz handles the entire administrative aspect of the busi-ness, and both of Katz's sons are interest ed in pursuing careers in the medical

"Both of them are pre-med," Katz said. "I've tried to impart to them that I think a medical profession is really unique in that you can excel at your work, and at

the same time you're doing something to help others.

After days full of patients, nights of Travis County Council for the Deaf meetings, and twice a month attending contin-

ings, and twice a month attending continuing education courses, Katz takes a breath of fresh air whenever possible.
"I love spectator sports," he said. "I try to make a lot of Westlake and UT gamesespecially football."

And he may be seen 'cruising' to a game in one of his other hobbies, automobiles.

"I love old cars, classic cars," he said.

No matter what the day, nor the activity. however. Katz doesn't lose focus of what's important to him.

"I think the strongest value I have is respect for my fellow man," he said. "I want to each day enjoy loving my fellow man and to enjoy being loved."



I read the letter praising the 911 service in Dear Ann Landers: Sacramento. This is to let you know that Stockton, CA., also has

a lot to brag about.

Three years ago, my husband collapsed in the middle of the night. I called 911, and the dispatcher kept me on the line, giving instructions on what to do until the emergency vehicle arrived. Before she rang off, she said, "Keep your courage up, and good luck, dear." Her warmth and concern made me feel as though a strong arm were around my shoulders. shoulders.

The paramedics were terrific. They had my husband breathing again in a minute and took him to the hospital. These same young men called

the hospital later to see how he was doing. My husband died four days later, but I will always be grateful to those wonderful people who tried to hard to save his life.

FROM SAN PABLO, CA: You asked how many other cities could brag about their 911 emergency services. Well, I live in San Pablo, and ours, too, is terrific. Three times, my wife had to call 911 on my behalf. Each time, the response came within three minutes. Twice, the paramedics needed to use lifesaving techniques. Another time, our neighbors called 911 because someone had broken into our house. To make emergency service work, two things are required: a good make emergency service work, two things are required: a good emergency service and alert, caring neighbors. We have both.



BIG LAKE, MINN: A thunderstorm knocked out our phone system. We live six miles from the nearest town, four miles from the main highway and 50 miles from the Twin Cities. Later that evening, a police car appeared. The officer asked if my husband and I were having "a domestic." I said, "No. My husband isn't even home." The officer said, "Well, we had a 911 signal from your phone, and the a dispatcher could not call you back, so we thought we'd better check it out." Our phone was fixed the next day.

GARLAND, TEXAS: My spouse and I manage an apartment complex. Recently, a child was playing with the phone and accidentally dialed 911 and hung up. Dispatchers called back and spoke with the mother. She said, "Everything is fine," but they kept her on the line and sent two police cars out to make certain. They arrived within three minutes. If our 911 service responds that well to a false alarm, you can rest assured they will be Johnny on the spot for real emergencies

LOUISVILLE, KY.: Several months ago I was awakened by a man who was throwing rocks at my bedroom window and tearing my screens. I am 29year-old single woman and this scared me to death. I called 911, and the lovely lady stayed on the phone until the police arrived. I thank my lucky stars the dispatcher was there - not only for instructions on how to defend myself but also for the emotional support, as well.


