#### Specialized Housing for Senior Citizens From TCDHH newsletter of March, 2001

Senior Citizens who are Deaf or Hard of Hearing often face limited choices when in need of housing with or without specialized care options. Texas is fortunate to have several facilities that provide specialized services for persons who are Deaf or Hard of Hearing.

**Granbury Care Center** has the only skilled long term care program for persons who are Deaf or Hard of Hearing in Texas, and one of three in the entire U.S. Modifications for visual alerting were made in rooms, and staff are on duty who can communicate with Deaf or Hard of Hearing residents. The coordinator of the program is fluent in ASL and provides interpreting for daily activities as well as for case management services. The staff is enhanced by an attending physician who has a strong interest in working with persons who are Deaf or Hard of Hearing and a psychologist who is late deafened and also fluent in ASL.

The Center ensures continuity of care by providing a complete realm of health care services. They offer a fully equipped therapy room with occupational, physical, respiratory therapies; specialized wound care program; speech therapists; complete respite care and day care. The Director of Deaf Services assists residents with scheduling doctor appointments, arranging for interpreting services, and scheduling transportation. D.E.A.F., Inc. has two certified sign language interpreters on staff, as well as case managers and other staff who communicate in ASL. This assisted living facility is licensed by the Texas Department of Human Services to provide financial assistance to those who qualify. # DEAF HISTORY

#### A Successful Deaf Landscaping Artist

<u>Granville Redmond</u>, tall, robustly built, with very thick wavy hair and round-rimmed wire glasses, was born on March 9, 1871 in Philadelphia, Pennsylvania. He was profoundly deaf from infancy. Redmond went with his parents to California when he was three years old. He never learned to speak. While at California School for the Deaf, his art instructor, Theophilus Hope d'Estrella recognized Redmond's artistic talent and encouraged him to continue his interests. Also, Redmond had another talent in the art of pantomime and did some entertainments on stage platform in the school chapel. Students enjoyed his performances.

Graduating in 1890, he received a financial support to study at Mark Hopkins Institute of Art in San Francisco from the Board of Directors of the California School. The board was so impressed with his abilities and decided to sponsor his continuous studies in Arts. After three years of his studies at Mark Hopkins School, Redmond was sent to Paris, France at the expense of the State of California to continue his studies at Academic Julian. His painting, "A Winter Scene on the Seine" was one of 500 paintings selected for admission to the famous Paris Salon. This painting was one of the best of his works. Redmond presented this painting to the California School for the Deaf in appreciation of the school's efforts to send him to Paris.

In 1898 Redmond was forced to leave Paris when his financial support was terminated. Although he would have loved to stay in Paris to be able to compete in future salons, Redmond knew California landscape was beautiful and unique and decided to reside in Los Angeles. He concentrated on painting the landscapes. A year later he was married to Carrie Ann Jean, a graduate of the Illinois School for the Deaf. They had three children.

When his painting, "California Landscape", became well recognized, Redmond was claimed as one of the leading landscaping artists and a bold colorist in southern California. His arts had been acknowledged in published local newspapers. One day in wintertime he fell on the pavement and fractured his right hand. His injury did not stop him from painting. Being ambidextrous, he went on painting with his left hand.

During World War I, the sale of his paintings diminished so Redmond decided to try his luck in the movies. Gottardo Piazzoni, Redmond's old friend who doubled as an interpreter, introduced Redmond to Charlie Chaplin, a world-famous comedian. Chaplin and Redmond became good friends. Chaplin had a collection of some of Redmond's paintings. "Low Tide" was Chaplin's favorite. He said, "Isn't it beautiful! That moonlight - it makes you feel you ought to whisper!"

Charlie Chaplin made many popular silent movies. He learned gestures and expressions from Redmond's art of pantomime. Gestures and expressions resemble sign language that Deaf people use. Redmond was hired to play some roles in Chaplin's movies. Redmond's studio was at Chaplin's movie lot in Hollywood where he did most of his paintings.

Redmond was listed in Who's Who in America and one of the few deaf artists mentioned in Fielding's Directory of American Artists.

Redmond died in July 1935 in Los Angeles. In his life he earned some awards: W.E. Brown Gold Medal from California School of Design in 1891, Medal from Louisiana Purchase Exposition in 1904, and Silver Medal from Alaska-Yukon Pacific Exposition in Seattle in 1909. He was a member of Bohemian Club, California Art Club, Laguna Beach Art Association, and San Francisco Art Association. His public collections exhibit at Bancroft Library at University of California at Berkeley; California School for the Deaf in Fremont; Languna Beach Museum of Art; Mills College Art Gallery; National Center on Deafness at California State University in Northridge; New York City Museum; Springville Museum of Art in Springville, Utah; and Stanford University Museum of Art. His life was full of productive efforts in his paintings and acting.
