#### Asparagus/Cancer

"Asparagus for Cancer" was printed in Cancer News Journal on December 1979. There was a discovery by Richard R. Vensal, D.D.S. that asparagus might cure cancer. A Professor at the University of Pennsylvania stated that asparagus was used as a popular remedy for kidney stones. He even referred to experiments on the power of asparagus in dissolving stones. For the treatment, asparagus should be cooked before using, and therefore canned asparagus is just as good as fresh. For the procedure: 1) Place the cooked asparagus in a blender and liquefy to make a puree and store in the refrigerator and 2) Give the patient 4 full tablespoons twice daily, morning and evening. Patients usually show some improvement in 2-4 weeks. It can be diluted with water and used as a cold or hot drink. Asparagus contains a good supply of protein called histones, which are believed to be active in controlling cell growth. For that reason, asparagus can be said to contain a substance that is called cell growth normalizer. That accounts for its action on cancer and in acting as a general body tonic. In any event, regardless of theory, asparagus used as we suggest, is a harmless substance.

#### Deaf Conroe man indicted on capital murder

While her deaf client has been indicted on a charge of capital murder in the stabbing death of his estranged wife, a Houston attorney said she doesn't believe that charge should stick because he "didn't mean to kill her." Willis police arrested Earl Handy Jr., 39, of Conroe, Jan. 16 for allegedly fatally stabbing Donna Allen Handy, 34, in her home. He also is charged with aggravated assault with a deadly weapon after allegedly injuring Handy's boyfriend, Joseph Taylor, of Conroe. Police previously said Handy waited outside his wife's home for the opportunity to confront her and Taylor. When Taylor opened the door to the single-wide mobile home in the Pin Oak subdivision shortly before 8 a.m., Handy allegedly stabbed him several times in the upper body. Police arrived to find Donna Handy stabbed in the chest, and she was later pronounced dead at Conroe Regional Medical Center. Earl Handy was found in the other end of the home, and police used their Taser stun guns to subdue him when he began stabbing himself, Willis Police Detective Alton Nelson previously said. Handy is still in the Montgomery County Jail with no bond amount set, according to jail information. His indictment states Handy intentionally caused the death of Donna Allen by stabbing her with a knife while committing or attempting to commit of burglary. A person commits capital murder "if the person intentionally commits the murder in the course of committing or attempting to commit kidnapping, burglary, robbery, aggravated sexual assault, arson, obstruction or retaliation, or terrorist threat" under the Texas Penal Code. The penalty for capital murder includes life in prison, life in prison without parole or death. Two sign-language interpreters have been appointed to Handy by the 9th state District Court of Judge Fred Edwards, according to records from the Montgomery County District Clerk's Office.





#### Dave Lieberman's Fettuccine Alfredo

Chef Dave Lieberman transforms this fatty pasta dinner into a healthy meal by replacing the cream and butter with a secret ingredient – cauliflower. This vegetable helps reduce the risk of breast cancer while also cutting the calories to less than half of the traditional dish! With only 6 ingredients, anyone can make this dish in a snap!

Ingredients Serves 2 1/2 lb cooked whole wheat pasta 1/2 head cauliflower, cored removed and broken into small florets 2 Tbsp olive oil 2 shallots, minced 1/2 cup chicken stock 1 cup grated parmesan cheese, plus more for garnish Salt and black pepper to taste

Directions: Steam the cauliflower for 20 minutes until very soft. In a small sauce pan, heat the olive oil over medium-low heat and cook the shallots until soft and translucent, stirring often, for about 10 minutes. Add the chicken stock and cook for 5 minutes longer. Set aside to cool.

In a large blender, combine the cooked cauliflower and the shallot-chicken stock mixture and purée until silky smooth. Pour the puree into the sauce pan and heat over medium heat until steaming. Remove from the heat, toss in the cooked pasta and add the grated parmesan cheese. Season to taste with salt and pepper and divide between 2 serving bowls. Top with more parmesan cheese. Calorie : 455 per serving



He was a life-long faithful member of the Dallas Association of the Deaf (D.A.D.) and was one of the association's biggest donors that helped the association to keep going strong. Bob was formerly president of the Dallas Association of the Deaf and also a dynamic leader in the Deaf bowling community. Bob was a chairman of the National Deaf Bowling Association (NDBA) in 1980. It was the most

successful event that NDBA had ever had. The Dallas Deaf community applauded the way he guided D.A.D. to obtain national recognition. The bowlers and fans had identified Bob as an all around American guy. Bob was also a long time avid Dallas Cowboy fan as well as a former Cowboys ticket holder. Bob had never missed his membership at the Deaf club since the day he joined the old Dallas Silent Club in 1951 and this continued when the members purchased a building, which also had two lots, on Maple Avenue in Dallas, in 1973. The name of this club was changed to the Dallas Association of the Deaf. D.A.D. tentatively plans to have a special dedication ceremony at the clubhouse in honor of Bob Wood's untiring and devoted life to the Dallas Association of the Deaf. # POOF and the light goes off


