


#### FAREWELL PARTY FOR MAURICE FORD

GINGER: Saves owner, perishes..

For 10 years, Ginger, the black Labrador was Rosemary Douglas' ears. Monday night, the dog was her savior. But it cost the animal its life. As Rosemary Douglas, who is deaf, sewed by herself while waiting for her husband to return to their Grand Haven Township mobile home, flames were creeping from the stove up a wall. Ginger, a specially trained dog for the deaf, came to warn her mistress of the impending danger.

"Ginger came into the room trying to get my attention." Rosemary Douglas said. "I thought she wanted water. Then I asked whether she wanted to go outside. That wasn't it either. And she got real frustrated and started going around circles. "That's when I went into the kitchen and there was a small fire." Rosemary, 52, who must use a wheelchair, tried to find a fire extinguisher but was driven back by the increasing intensity of the flames that were now shooting up a wall inside the home. She and Ginger were forced to the back entrance. And when she opened the door, the fire exploded; she and Ginger were hit from behind with an explosive blast of hot air. She landed outside face down with the wheelchair on top of her. "When I got up, Ginger ran back inside looking for (my husband) Roger because that's the time he was supposed to be home from work. I never saw her again," she said.

Responding fire units from Grand Haven Township later would find the dog's body in the Douglas' bedroom next to the bed. "She wasn't trained to go after Roger, but that's what she was doing," Rosemary said. "She did it on her own." Close to 24 hours later, the Douglases buried Ginger, who was 14, in the back yard of Rosemary Douglas' parents home in Muskegon. "I'm really going to miss her," Rosemary said. "We were together all of the time."

According to Grand Haven Township Fire Lt. Wes Collins, the fire was reported at 8:42 PM Monday in the River Haven Mobile Home Park. By the time units arrive, much of the Douglas home was engulfed in flames. Although crews were able to quickly extinguish the fire, the \$60,000 home was destroyed. Also destroyed were the contents, valued at \$20,000. Roger Douglas, 42, who works at Grand Haven's Engine Power Components, said the structure was fully insured and he was confident they soon would be able to buy a new home. Through the American Red Cross of Ottawa County, they were staying for the next three days at a Grand Haven motel. "It could have been worse," Roger said. "My wife owes her life to that dog."

According to fire investigators, the blaze started near the oven, in which two pot pies were baking at that time. Collins said the fire exploded through much of the home after the back door was opened. Ginger died from smoke inhalation, Collins said.

Roger said Ginger was obtained through the Paws with a Cause program in Grand Rapids, which provides specially trained dogs to the disabled. Ginger's training was extensive and included being taught to lift a ringing telephone off the receiver and to alert her owners to a ringing door bell. Ginger also was taught how to remove a baby from a crib in case of danger. Rosemary recalled that back in 1991, Ginger kept a youthful mugger at bay in Muskegon.

The two already have contacted Paws with a Cause and hope to have a new dog soon. "There typically is a year wait," Roger said. "We're hoping we can get one sooner."

#### CHRISTMAS PUNCH

4 c. orange juice

6 c. cranberry juice

1 c. water

3 tsp. Whole cloves 3 tsp. Ground allspice 1 whole nutmeg, crushed Cinnamon sticks (about 3 inches)

#### FIELD TRIP TO NEW BRANUFELS

On Wednesday, November 15, 2000, about 24 Houston Deaf Senior Citizens had a field trip to New Branufels to visit New Braunfels Museum of Art. The museum, the former First Federal Savings and Loan building, opened to exhibiting Hummel collectibles and original paintings by Sister Maria Innocentia, the former Berta Hummel in October of 1992. A 30 minutes tape about a life of Sister Hummel in

Germany and her talent artwotk was displayed and then the group toured to see many beautiful collectibles of Hummel. Berta Hummel arrived at Siessen Convent in the late spring of 1931. She took her vows and become a nun in 1934. Her name was changed to Sr. Maria Innocentia after taking the vow, who loved to sketch, draw and paint children, often taking her inspiration from the children who lived near her convent. While at the convent, she taught art at a secondary school for girls and she often reward the children's good work with a religious picture she had created herself. At the young age of 37, Sr. Maria Innocentia had died of tuberculosis on November 6, 1946. Her artwork and the figurines still bear her name ever since.


#### From Sandra Barnes-Smith of Austin, Texas
