Coffee filters ..who knew!

And you can buy 1,000 at the Dollar Tree for almost nothing.

COFFEE FILTERS: Not just for making coffee....

1. Cover bowls or dishes when cooking in the microwave. Coffee filters make excellent covers.
2. Clean windows and mirrors. Coffee filters are lint-free so they'll leave windows sparkling.
3. Protect China . Separate your good dishes by putting a coffee filter between each dish.
4. Filter broken cork from wine. If you break the cork when opening a wine bottle, filter the wine through a coffee filter.
5. Protect a cast-iron skillet. Place a coffee filter in the skillet to absorb moisture and prevent rust.
6. Apply shoe polish. Ball up a lint-free coffee filter.
7. Recycle frying oil. After frying, strain oil through a sieve lined with a coffee filter.
8. Weigh chopped foods. Place chopped ingredients in a coffee filter on a kitchen scale.
9. Hold tacos. Coffee filters make convenient wrappers for messy foods.
10. Stop the soil from leaking out of a plant pot. Line a plant pot with a coffee filter to prevent the soil from going through the drainage holes.
11. Prevent a Popsicle from dripping. Poke one or two holes as needed in a coffee filter.
12. Do you think we used expensive strips to wax eyebrows? Use strips of coffee filters.
13. Put a few in a plate and put your fried bacon, French fries, chicken fingers, etc on them. Soaks out all the grease.

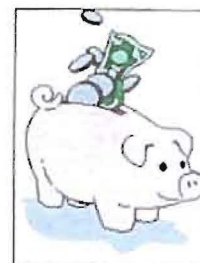

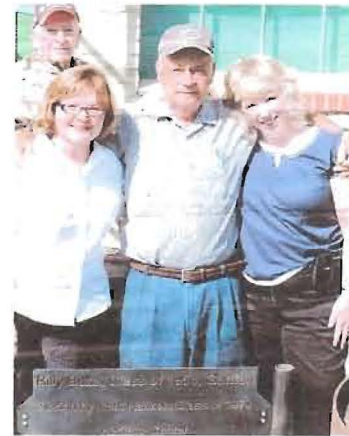

Army, J-K Police probe deaf and dumb man's killing

FATAL ERROR? Army shot dead a man in Kashmir not knowing that he was deaf and dumb.

Kashmir: In Jammu and Kashmir, a controversy is brewing at the new Chief Minister Omar Abdullah's doorsteps.

A 45-year-old deaf and dumb man was shot dead by Army personnel on Tuesday night as he was found trespassing about 200 metres from Omar Abdullah's residence. The man later identified as Abdul Rashid Reshi and the Army is now claiming that he tried to scale over a boundary wall with an intention to conduct reconnaissance for a suicide attack. However, family members of Reshi say he was unarmed and just holding a kangri. "He was coming to meet us. He was my brother-in-law and was deaf and dumb. His mental faculties were alright. The Army killed him. Police also say the same," Jawahira Reshi, a relative of Abdul, said. Police have registered a case and started investigations. "A police team is at the spot to investigate," Inspector General of Police Kashmir Range B Srinivas said. The Army, too, has instituted a high level inquiry into the incident. Army official say a brigadier-rank officer will head the investigation. Meanwhile, Omar Abdullah who recently said that human rights would be respected, faces an acid test over the incident.

CSD Receives \$1.1 Million FCC Grant to Implement Nationwide Awareness Campaign About Transition to DTV

SIOUX FALLS, S.D. (Jan. 8, 2009) - Communication Service for the Deaf, Inc. (CSD) today announced that it has been awarded a \$1.1 million grant from the Federal Communications Commission (FCC) using funds that were appropriated by Congress last year for DTV outreach. The grant will be used to launch a national awareness campaign about the country's transition to digital television (DTV).

On Feb. 17, America's entire television network infrastructure will transition to a digitally based broadcast signal. Unless a digital converter box is obtained and installed, over-the-air analog viewers will not be able to receive a television signal. Congress has encouraged broadcasters and the FCC to implement massive awareness campaigns to better educate the public about this upcoming change. It is expected that millions of Americans will be contacting information centers for more details. CSD is one of 12 recently identified organizations to help with outreach efforts and technical assistance.

"We are delighted to receive this award from the FCC and are very enthusiastic about developing an educational awareness initiative for citizens all across the nation," stated Benjamin J. Soukup, CSD president and CEO. "We are also pleased that special attention is being given to key population groups--minorities, senior citizens, the disabled, and others--which are otherwise overlooked. Sensitivity to equal access and equal accommodations is something we have staunchly advocated for and the funding of projects like this is most definitely a move in the right direction. We look forward to other future opportunities just like this one to ensure that all citizens--including those who may be deaf or hard of hearing--have equal access to information and communication when important announcements like this one must be made."

CSD will immediately create and release deaf oriented PSAs, disseminate educational materials, conduct seminars, answer calls from an established call center, help viewers get and install DTV-to-analog converter boxes, educate consumers about the use of DTV closed captioning services, provide technical assistance, and more. Within weeks, deaf and hard of hearing consumers will be able to contact CSD's Help Center via regular voice phone service or by using videophones, the Web, IM Chat, Relay Services, IP Relay, Voice Carry Over, Captioned Telephone (Cap-Tel), Video Relay Services and Spanish Video Relay Services to make inquiries.

The duration of this project is expected to last throughout the next six months and CSD hopes to aggressively work with several other national groups and organizations to reach America's 28 million deaf and hard of hearing people. CSD Favors Efforts to Delay Nation's Transition to DTV

Sious Falls, S.D. (Jan. 16, 2009)—CSD today announced that it supports the combined efforts of president-elect Barack Obama's administration and Senators John Kerry (D-MA) and John D. Rockefeller IV (D-WV) — incoming Chairman of the Committee on Commerce, Science and Transportation—to delay the upcoming digital television (DTV) transition from Feb. 17 to June 12 of 2009. Such a delay would help provide analog TV consumers with additional time to avoid being left with no television signal after the cutover date. On Feb. 17, America's entire television network infrastructure is set to transition to a digitally-based broadcast signal. Unless a digital converter box is obtained and installed, over-the-air analog viewers will not be able to receive a television signal. For the past 3 years, broadcasters and the FCC have tried to implement public awareness campaigns to better educate television viewers about this upcoming change. Unfortunately, the coupon program, designed for Americans who cannot afford the \$40-\$60 converter boxes, has been plagued with problems and specific efforts to reach out to key population groups have only just begun. Most importantly, there are still a number of technical issues to be addressed as the transition date approaches. With only 30 days before the transition occurs, postponing the cutoff date, as argued by many, would be advantageous. In fact, the benefits of a delay do seem to far outweigh the disadvantages.

As Senator Rockefeller pointed out in his introduction of a proposed bill to officially postpone the date, such a delay would: 1) help Americans who are still unaware, confused or unprepared for the transition, 2) reduce public safety risks regarding alerts for public disasters and inclement weather, 3) better allow federal and public agencies to adequately prepare, 4) allow the new administration a chance to fix the DTV coupon program, 5) provide more opportunities for local community coordination, 6) reduce physical safety risks of crews who must work on towers and lines during winter weather conditions, and 7) provide a chance to address remaining technical issues.

In particular, CSD is extremely concerned with technical issues related to captioning and digital television signals. Captioning allows viewers to access television programming via text by visually displaying the audio portion of a television program. In 1996, Congress required video programming distributors to close caption television programs, with certain exemptions (47 U.S.C. § 613). This law has been implemented pursuant to rules issued by the FCC which require captions on both analog and digital TV programs. We must work with broadcasters to make sure they are sending signals with captions that can be decoded by equipment that consumers use. As we work to resolve these issues, we'll need to make sure that our CSD help center staff who receive contacts from the public are familiar with the issues, know how to give advice or information to the callers and can adequately assist them.

CSD is one of the 12 organizations identified across the nation on Jan. 6 to help the FCC with outreach efforts and technical assistance. 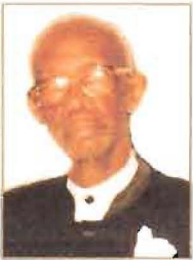
REST IN PEACE
