# FREE HEARING LOSS WORKSHOP SLATED FOR DECEMBER 4 IN LIBERTY, TX

A hearing loss workshop entitled "I Can Hear You, But I Cannot Understand You," will be held at the Sam Houston Regional Library and Research Center, 650 FM 1011 in Liberty, on Thursday, December 4 from 8:30 a.m. to 4:30 p.m. (Bring your own lunch as we will tour the facility during lunch.) Sponsoring groups are the Texas Department of Assistive and Rehabilitative Services (DARS), Office for Deaf and Hard of Hearing Services, and Communication Axess Ability Group (CAAG).

The main presenter is Teri Wathen. Ms. Wathen is a Hearing Loss Resource Specialist of CAAG and has been giving presentations on hearing loss for many years. Her husband and two sons all have hearing loss, and Wathen wears two cochlear implants herself. Other speakers include Chris Conway who will talk about the free phone voucher program; Ashley Fairleigh who will talk about the latest on cochlear implants; and Jose Gonzalez who will go over communication tips and his contract with the state in the eastern counties of Texas.

Topics that will be covered in this FREE workshop are psychosocial issues of hearing loss, communication strategies in the workplace and at home, the latest on cochlear implants, assistive communication devices, and resources. Six hours of CEU credits have already been approved for audiologists, speech-language pathologists, hearing aid dispensers, social workers, sign language interpreters, early childhood interventionists, and occupational therapists. ## Disclosing Disability: When and if to Disclose

This training will focus on the factors to consider when making the determination to disclose disability to a potential employer. Many people are not trained on how to make this determination and need to have the appropriate tools to be able to make informed decisions about "if and when" to disclose disability. Randi Turner serves as the Communications Access Specialist at DARS Office for Deaf and Hard of Hearing Services. She works with agencies and service providers regarding their access obligations under the Americans with Disabilities Act and the Rehabilitation Act. Her training empowers people who are deaf or hard of hearing with knowledge of their civil rights and provides advocacy skills.
