HEALTH TIP

“Stunning Health News About Hot Cocoa!”

Sweet! Hot cocoa really is good for you. Sip a steaming mug of hot cocoa and you'll get more disease-fighting antioxidants per cup than a similar serving of red wine or tea, report researchers from Cornell University.

Cocoa's antioxidants are almost two times stronger than red wine, two to three times stronger than green tea, and four to five times stronger than black tea, reports Science Daily. Antioxidants—vitamins C and E and beta carotene—are widely believed to fight cancer, heart disease, and aging. They may even help stave off the memory-robbing Alzheimer's disease.

The Cornell study is the most extensive comparison yet of the total antioxidant content of cocoa, wine, and tea, arguably the world's most popular drinks after water. There's just one problem with all this: Scientists know antioxidants are essential for our good health and longevity, but they don't yet know how much we need every day.

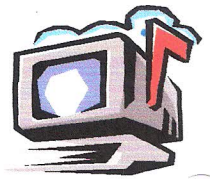
If you want to get your antioxidant dose from something sweet, there is nothing better than hot cocoa. And the key word here is “hot.” Lead study author Chang Yong Lee says hot is better than cold. For some reason, when cocoa is heated, more antioxidants are released than when it's cold. Don't want the fat and extra sugar of hot cocoa? Use skim or soy milk instead of whole milk and an artificial sweetener instead of sugar.

The study findings appear in the Journal of Agricultural and Food Chemistry.

Dear Houston Senior Citizens and Friends:

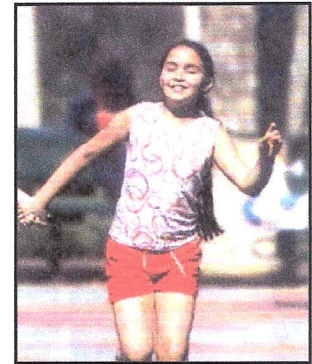

Cancer Awareness

Cancer affects everyone differently. It can be found in many parts of the body, such as the breast, prostate, lung and even the brain. Scientists are unsure how cancer starts. There are things you can do to decrease your chance of developing it. Here's how:

3. Quit smoking.
4. Limit your alcohol use.
5. Wear sunscreen when going outdoors.
6. Talk to your doctor.

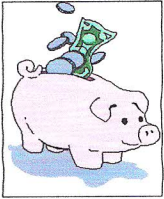

Remember Caution

C = change in bowel or bladder
A = a sore that does not go away
U = unusual bleeding or discharge
T = thickening or lump in the breast
I = indigestion or difficulty in swallowing
O = obvious change in wart or mole
N = nagging cough or hoarseness

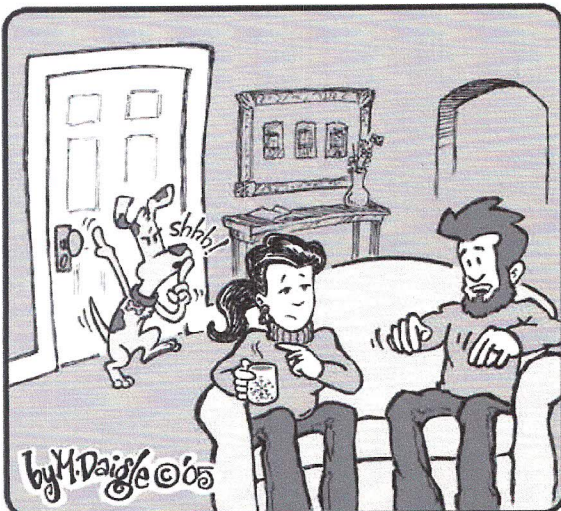

Joseph Katz, 89, beloved husband, father, and grandfather, passed away on Saturday, March 5, 2005, after a long battle with congestive heart failure. He was born in St. Paul, Minnesota, on January 1, 1916 one of seven children. He attended the Minnesota School for the Deaf and in

1938 married Rose Raben, who attended the Iowa School for the Deaf. They celebrated 67 years of loving marriage this year.

With Rose, Joe lived in Fort Worth, Houston, and -- for the last fifteen years -- in Austin, so that he could be close to his son, Jerry Paul Katz, his daughter-in-law, Carrin, and his grandsons, Stephen Katz and David Katz, along with David's wife Shelly. Joe was an extremely proud grandfather at the age of eighty-nine. He was proud of his achievements in life, but would most often speak of his pride in his son and two grandsons, who he would lovingly refer to as his three doctors: Jerry is a dentist, David is a physician, and Stephen is working on his Doctorate in English Literature. Joe always felt that this was a real accomplishment for a hearing-impaired person, who came from a very modest family of seven, and who had little money and no college education.

Nevertheless, Joe did learn to work hard and aim high, and he passed that belief on to his son and grandsons. At the age of seven, Joe and his brothers began selling newspapers on the street corner in Saint Paul, Minnesota. Joe earned money at an early age to support himself and contribute to his family's needs. He even polished shoes at the state fair of Minnesota. These early lessons in selling made him comfortable around the hearing, and made him so confident about selling that he had his own business selling automobile parts and tools for over thirty-two years in Fort Worth and Houston. He retired in 1990, at the age of seventy-four, when he and Rosie moved to Austin. However, he continued to sell as he helped Rosie with her business selling products for the hearing-impaired. Family and friends will always remember him as a cheerful and positive person, whose kindness and friendliness were open to everyone.

He was an avid supporter of the Westlake High School football team, and rarely missed a game over the last ten years. He was also active in the Deaf Senior Citizens group, and a longtime supporter of the Texas School for the Deaf.

Joe is survived by his wife Rose, his son, Jerry Paul Katz and his wife Carrin; grandsons, David Katz and his wife Shelly, and Stephen Katz; his two brothers Oscar and Morris Katz; and many nieces and nephews.

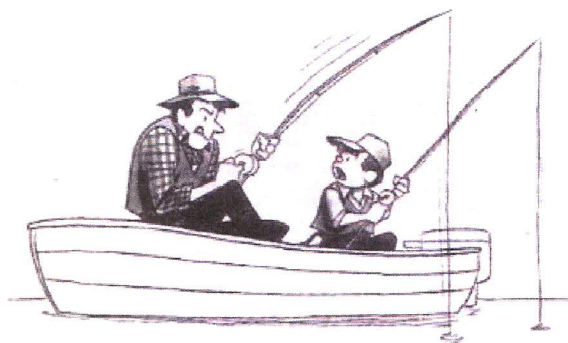

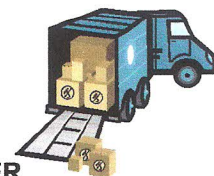
