## **FROZEN LEMONADE PIE**

Submitted by Rochelle Simpson

For the crust: 2 cups Graham Cracker Crumbs, 1/4 cup Sugar, and 7 Tbsp Unsalted Butter, melted.

For the filling: 2 cups Heavy Cream; 1 14-oz. can Sweetened Condensed Milk, chilled; 16-oz. can Frozen Lemonade concentrate (Do not thaw).

For the Topping: 1 cup Blueberries; 1 cup Raspberries; 2 Tbsp Sugar; and 1 Tbsp Fresh Lemon Juice.

1. Preheat the Oven to 350. Make the crust in a medium bowl by combining the Graham Cracker Crumbs, sugar, and melted butter. Press firmly on the bottom and up the sides of a 9-inch pie plate. Bake for 7 minutes and cool completely.
2. Make the filling, in a cold medium bowl by whipping the cream until stiff peaks form. In another bowl, stir together the condensed milk and frozen lemonade. Gently fold the lemonade mixture into the whipped cream. Pour the filling into the crust and freeze overnight.
3. About an hour before you serve the pie, make the topping. Toss the berries in a medium bowl with sugar and lemon juice. Set aside until ready to serve.
4. Let the pie come to room temperature for 10 minutes before cutting. Top each slice with berries.

## OBITUARY

A devoted husband, a loving father, grandfather, great-grandfather and friend, **Frank Randall Nye, Jr.**, 76, found no greater joy than being surrounded by his family. He served as an attorney and counselor for fifty-five years. Born in Laredo, TX, on Sept 23, 1922, to Frank Randall and Ozema Nye, Randy graduated from Martin High School in 1940. He was a graduate of Texas A&M College in College Station, TX, and was a proud member of the "Class of 1944" and Texas Aggie Corps of Cadets. On Dec 8, 1941, he volunteered for the U.S. Army. He was sent to Camp Roberts, in San Bernardino, CA, for infantry training, and he was later transferred to the U.S. Army Signal Corps., in Sacramento, CA. When he attended Signal Corps Officer Candidate School in Monmouth, NJ, he graduated at the top of his class. Randy was then assigned to undergo World War II Signal Corps Training at Camp Crowder, MO. As a Message Center Officer with Unit 3101 Signal Service Battalion, he was sent to the China-Burma-India Theater on Troop Ship U.S.S. General McRae, reaching Calcutta on Feb 20, 1945. As Communications Officer, he served as Ship Officer and Top Secret Officer. From Calcutta, he was sent to the Burma Road and placed in charge of top secret codes for all of the C-B-I Theater where he was stationed. He was in command of the last convoy out of the Burma Road region. Then, he was sent from China to Theater headquarters in New Delhi, India, where he remained until he was transferred to China Theater Headquarters in Shanghai. After an honorable discharge and back to living the life of a civilian, Randy returned to Laredo and soon enrolled in the University of Texas School of Law in Austin, TX where he was a member of Phi Alpha Delta Law Fraternity. During that time he started courting Ms. Conna Jean Newton, the love of his life. He received his Doctor of Jurisprudence degree in 1950. Randy was admitted to practice in the United States of America Supreme Court, Washington, D.C., U.S. 5th Circuit Court of Appeals, Texas Supreme Court, and Texas 4th Court of Civil Appeals, San Antonio. He served as County Attorney and County Judge of Starr County. He was District Attorney, 229th District, for Starr, Duval and Jim Hogg Counties. In 1972, he retired from public office and went into private practice in Starr County. Nye was a rancher, hunter and outdoorsman. The best times in his life were spent at the ranch with family. He was a master story teller, and it was during these times that he would keep everyone captivated by the stories of a young boy spending precious time with his beloved mother and father. He is survived by his wife, Conna Newton Nye; son, William Alfred (Al) Nye & his wife, Yasmina, of Mission, TX; daughter Nancy & her husband, William (Mike) Comer, of Austin; son, Raymond Randall (Ray) Nye, Sr., of Marble Falls; a son James Lloyd (Jimmy) Nye & his wife, Janice of Mission; grandchildren-Randall Boone LaGrange & his wife, Holly, of Houston; Cari LaGrange Murphy, Houston; Jennifer LaGrange Davenport & her husband, John, of Atlanta, GA; Harper Nye Hudsonpiller and her husband, Steven, of Mountain Home; Micajah Autry Nye of McAllen; Daphne Nye Archer & husband, Jason, of Sharyland; Megan Nicole Nye of Austin; Raymond Randall (R.J.) Nye, Jr., of Austin; Frank Randall (Sonny) Nye III of Mission; and beloved great grandchildren. He is survived by one sister, Ollie & her husband, Bill Lowry, of New Braunfels. He was preceded in death by his baby daughter, Marian Jean; his parents, Frank and Ozema Nye; and sister, Lorraine Fansler.
