#### Field Trip on June 17th

Will Park's father, Calvin, was raised in Union Valley, NY and decided to try his luck in the west. His homestead was at the corner of the present Shaver and Highway 225. This house is a typical home of our area during its strawberry patch beginnings.

He took his case to Court where a Lubbock County jury has decided Texas Tech University should pay him more than \$500,000 for discriminating against him because he is deaf. #### **Princess Alice of Battenberg**

Princess Alice of Battenberg, later Princess



Andrew of Greece and Denmark (Victoria Alice Elizabeth Julia Marie was born February 25, 1885 and passed away on December 5, 1969) was the mother of Prince Philip, Duke of Edinburgh, and mother-in-law of Elizabeth II. She was congenitally deaf, and grew up in Germany, England, and the Mediterranean. After

marrying Prince Andrew of Greece and Denmark in 1903, she lived in Greece until the exile of most of the Greek royal family in 1917. On returning to Greece a few years later, her husband was blamed in part for the defeat of Greece in the Greco-Turkish War (1919–1922), and the family was once again forced into exile until the restoration of the Greek monarchy in 1935. In 1930, she was diagnosed with schizophrenia and committed to a sanatorium: thereafter, she lived separately from her husband. After her recovery, she devoted most of her remaining years to charity work in Greece. She stayed in Athens during World War II, sheltering Jewish refugees, for which she is recognized as "Righteous Among the Nations" at Yad Vashem. After the war, she stayed in Greece and founded an Orthodox nursing order of nuns known as the Christian Sisterhood of Martha and Mary. After the fall of King Constantine II of Greece and the imposition of military rule in Greece in 1967, she was invited by her son and daughter-inlaw to live at Buckingham Palace in London, where she died two years later.
