

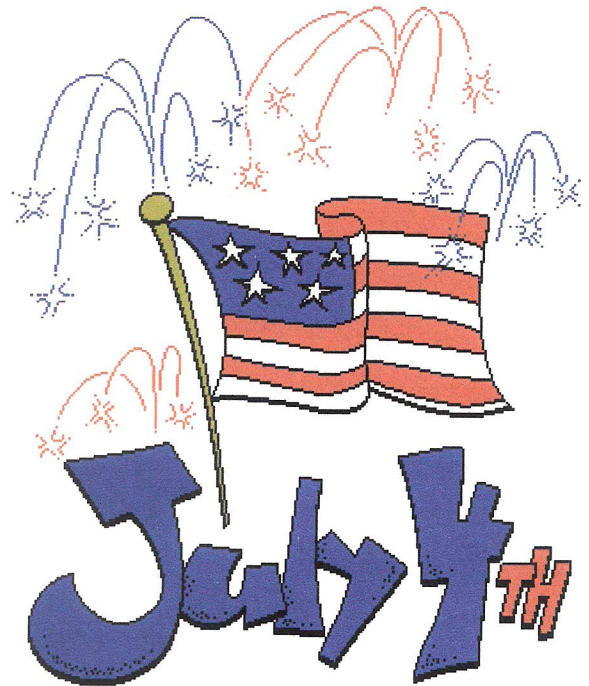

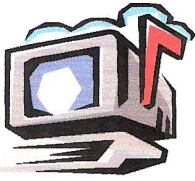

Houston, July 11, 2003**

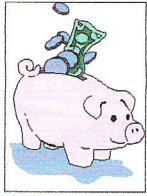

THE SITUATION WITH TCDHH

The Texas legislature completed their session on June 2. This was a session where they faced an expected \$9.9 billion revenue shortfall for the next two years. TCGHH (Texas Commission for the Deaf and Hard of Hearing) went through the usual budget procedures and the funding situation for the two years, which starts September 1, 2003, will allow most of the agency's programs to function at basically the same levels as in the past few years. Travel will be restricted. We cannot pay travel expenses for task force meetings. The BEI may have to reduce the number of testing dates... There may be a freeze on hiring and other cost saving measures.

The really big impact of the legislative session involves the merger of health and human services agencies. All of these agencies, including TCDHH, will be merged into one of four new departments under the Health and Human Services Commission. TCDHH will be merged into the Department of Assistive and Rehabilitative Services, along with the Texas Rehabilitation Commission (TRC), Texas Commission for the Blind (TCB), and Early Childhood Intervention (ECI). The Commissioner, Health and Human Services Commission, and the Governor will select an Executive Director for each of the new departments. Each new department will have an advisory council with members appointed by the Governor. A Transition Legislative Oversight Committee will be appointed and given the responsibility to draft a plan and make recommendations for the mergers. This Committee will have two Senate members, two House of Representatives members, and three members selected by the Governor. Their plan and recommendations will be due in December 2003 and will go to the Governor. This plan is expected to include some organizational structure and timelines for the mergers. At some point after December 2003, TCDHH and all the agencies being merged will be abolished. This will include abolishing the boards of all the agencies. This will be the largest government reorganization in the history of Texas and it could take several years to accomplish.

No information is available regarding what will happen to TCDHH services. However, the legislative intent was to cut costs and not to eliminate or reduce services. It is reasonable to expect that most TCDHH services will be retained and administered by the new department. It is also reasonable to expect that most, if not all, TCDHH staff will be retained by the new department.

The TCDHH staff and I will do what we can to encourage the establishment of an Office for the Deaf and Hard of Hearing within the Department of Assistive and Rehabilitative Services. We are committed to seeing that the population of persons who are deaf or hard of hearing will continue to be served and that the new department will work with and be supportive of the contracted councils throughout the state. Albert Hawkins, Commissioner, Health and Human Services Commission, has assured me that he is committed to structuring the new Department so as to be responsive to the people it serves.

Thanks to all who have been supportive of TCDHH in the legislative session by attending hearings at the capitol, by sending letters, emails, faxes and by making calls to legislators.

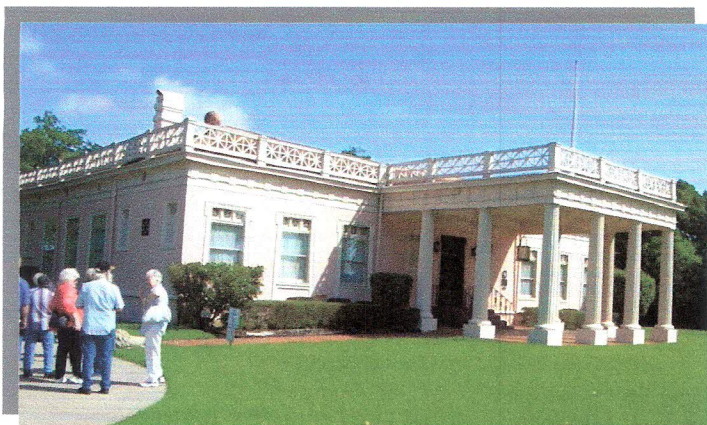

## ← Pompeiian Villa

This building's history is almost as fascinating as the villa itself. Typically Pompeiian are the Doric Columns that support the portico as well as the latticework that rims the roof and the small windows that top the building's larger windows. That was an authentic copy of a Pompeiian home of 74 AD with the 20 rooms built around a traditional Roman peristyle. Also borrowed from ancient Pompeii is the deep pink color of exterior walls and lighter shade used for the columns and contrasting trim.

→ This is a three-sided courtyard of Pompeiian Villa to which each room has access.



## Queen of Peace Shrine & Gardens

This Hoa-Binh (Area of Peace), featuring beautiful gardens and statue of *Mary* 3 time's life size was built by parishioners of Queen of Vietnam Martyr's Catholic Church. *What a unique statue!*



## White Haven

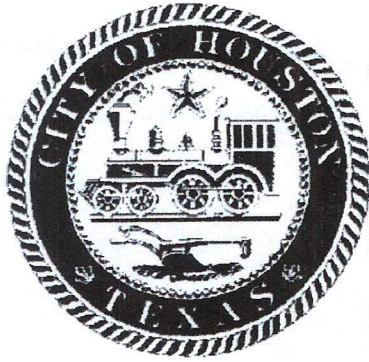
Originally build as a New England colonial-style mansion in 1915, it was changed by a subsequent owner to a Southern Greek Revival style by the addition of large verandas and columns. The last owners of the house filled it with a large collection of Victorian furnishings and other antiques, which are so beautiful.

The home is now owned by Lamar State College-Port Arthur and used for a variety of campus meetings, gatherings, and functions.

## HOW TO PREPARE FOR A HURRICANE

1. **LISTEN** to local emergency officials, and follow their instructions. Listen to local TV and radio. (KTRH\_AM 740 is the designated Emergency Alert Station for the Houston Area).
2. **HAVE A PLAN** of action for any emergency. If you must relocate, have a predetermined destination, route and alternate route – whether out of the area or to the nearest shelter.
3. **PREPARE:**

Have these emergency supplies:

- Non-perishable foods and water containers.
- More than one flashlight and extra batteries.
- First-aid kit, along with any prescription medicine.
- Stored plywood – preferably heavy and pre-cut and pre-drilled to cover windows.
- Plastic sheeting – for water leaks.

Know the difference between a hurricane **WATCH** and a hurricane **WARNING**.

A hurricane **WATCH** is issued when a hurricane becomes a threat to this coastal area within 36 hours. Everyone in the area covered by the watch should listen for further advisories and be prepared to act promptly if a hurricane warning or relocation is recommended.

A hurricane **WARNING** is issued when hurricane winds of 74 mph or higher, or a combination of dangerously high water and rough seas, are expected within this area within 24 hours. Precautionary actions should be completed immediately.

When a hurricane **WATCH** is issued:

- Continue to monitor local TV or radio stations for instructions.
- Check supplies, especially water (at least 5 gallons per person).
- Fuel your vehicles and generators.
- Cover windows with plywood.
- Bring in **ALL** outdoor furniture, toys and tools.
- Moor any boats securely, or move it to a safe place.

When a hurricane **WARNING** is issued:

- Continue to monitor local TV or radio stations for instructions.
- Move early out of low-lying areas or from the coast, at the request of officials.
- Check tie-downs if living in a mobile home, and leave immediately.
- If you live on high ground, away from the coast and plan to stay, secure the building, windows and garages and follow all procedures listed above, plus store extra water in bathtubs and all available containers.
- Turn off utilities, if requested.
- Stay away from windows, doors and openings.

## HURRICANE SUPPLIES

What supplies do you need in case of a hurricane? The Federal Emergency Management Agency and the Red Cross Recommend:

### ➤ WATER

- Store at least one gallon of water per person per day in plastic containers such as soft drink or mild bottles.
- Keep at least a three-day supply of water for persons in your household. (Five gallons per person overall is recommended.)

### ➤ FOOD

Store at least a three-day supply of nonperishable foods that require no refrigeration, little preparation or cooking, and little or no water, for example:

- Canned meats, fruits and vegetables
- Canned juices, milk, soup
- High-energy foods such as peanut butter, jelly, crackers, granola bars and trail mix
- Vitamins
- Cookies, hard candy, cereals, instant coffee

### ➤ TOOLS & SUPPLIES

This includes:

- Paper Cups and plate
- Plastic utensils
- Battery-operated radio
- Flashlight
- Batteries
- Cash
- Fire Extinguisher
- Pliers
- Compass
- Manual can opener (non-electric)
- Matches in waterproof container
- Signal flare
- Map of the area
- Sanitation items

### ➤ FIRST-AID KIT

A first-aid kit for your home and each car should include:

- Sterile adhesive bandages
- Gauze pads
- Adhesive tape
- Scissors
- Tweezers
- Needle
- Antiseptic
- Thermometer
- Soap
- Aspirin
- Anti-diarrhea medication
- Antacid
- Laxatives

### ➤ CLOTHING & BEDDING This includes:

- Sturdy shoes or work boots
- Rain gear
- Blankets or sleeping bags
- Hat and gloves

## DURING A HURRICANE....

Remain indoors during a hurricane. Stay in the lowest level of your home well away from any windows. An interior hallway, bathroom or closet may be the safest location. Remember to cover members of your family with a mattress or to seek shelter under something very sturdy like a well-constructed dining room table that could protect them from possible debris.

## REMEMBER....

Make your hurricane plan a part of a family discussion. Share your plan with friends and relatives. Hurricane preparedness is a team effort for everyone in the neighborhood and community.

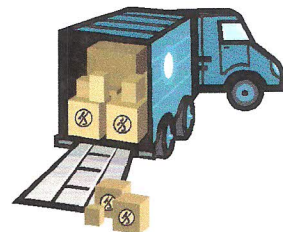
